### School Attendance Dues

#### **Attendance Dues**

Attendance Dues are a compulsory payment under the terms of the Private Schools Conditional Integration Act 1975 and a conidtion of enrolment at Stella Maris Catholic School. Attendance Dues are charged for all students who attend Catholic Schools in New Zealand.

Attendance Dues are used to repay loans for building works done at schools in the Auckland Diocese, property related costs including school building work, buildings insurance and costs directly associated with the administration of attendance dues.
